Updated Covid protocols for the Calgary Firearms Centre effective immediately:

Unfortunately due to the restrictions received from Alberta Health Services and in keeping with our commitment to public safety, we are implementing additional restrictions for at least the period of additional high case area restrictions relative to the current CMOH - 19, 2021 order is lifted or modified.

- 1) Outdoor group activities including events / tournaments are now prohibited.
- 2) The trap and skeet fields as well as the 5 stand can remain open to individual or permitted households on a booking basis only. No group bookings are permitted at this time. This means no events, no tournaments and no competitions. All currently scheduled events/tournaments scheduled for May are postponed at this time.
- 3) Youth and Women's league will only be allowed if individuals or households / cohort groups come independently to shoot and record their scores after booking an appropriate time.
- 4) Staggered shooting times will be set up for the facility on all fields and a booking time is required to attend. Attendees are required to shoot at their designated time slot and depart the property as soon as they have completed their session.
- 5) The clubhouse remains closed and food service remains suspended. The gathering area for people to eat that has been set up on the south side of the building will be disbanded and tables will be scattered around the property randomly for sitting/resting but cannot be set up as a dining area.
- 6) Washrooms will remain open and our sanitization procedures continue with diligence. We will aggressively enforce the social distancing guidelines throughout the property including the parking areas.
- 7) Stanchions and directional signage must be obeyed regarding social distancing. Please use the hand sanitizer provided or bring your own. Wash your hands regularly.
- 8) Individual coaching and training which requires the coach to be within the specified 6 foot safe space zone is suspended until further notice.
- 9) Masks are mandatory for entry to the building to use the washrooms and are highly encouraged as you move about the property. Masks can be removed when on the line or within your cohort/family group.

While these restrictions seem severe, and as difficult as it is to accept, we are clearly working to ensure we are part of the solution not the problem. Hopefully as the "High Case area restrictions" are lifted for Foothills County, we can revisit these orders and modify them accordingly. In the meantime, your assistance in creating an environment that helps bend the curve and control these latest outbreaks is greatly appreciated. Thank you for your understanding... please stay safe, test negative, think positive and understand that this too shall pass.
